NOTE: An example of a prominent World War II recallee is General John McAuley Palmer, analyst of US military manpower policy and advocate for civilian-based army. He was recalled to active duty specifically by Chief of Staff George C. Marshall and served as "elder military statesman." See I. B. Holley, Jr., General John M. Palmer, Citizen Soldiers, and the Army of a Democracy (Westport, CT: Greenwood, 1982; E745P25H64).

Another obvious example is Douglas MacArthur, who rendered his most distinguished service <u>after</u> 30 years of service and official retirement in 1937.
