## **REPATRIATION & RAMPS, EUROPE, 1945-46**

### A Working Bibliography of MHI Sources

The liberation, recovery, and repatriation of Allied prisoners of war in enemy hands had been agreed upon beforehand among the Allies. Recovered Allied Military Personnel (RAMPS) were to be well-cared for by the liberating forces and returned expeditiously to their respective nation's control. Many Soviet ex-POWs who ended up in American, British & French custody did not wish to return to their homeland, but were ultimately repatriated.
