Organization: This working bibliography is divided into three sections:

- **I.** Manuscripts including family papers, personal and official documents, and unpublished memoirs of varying lengths. The following describe these entries:
- A) The date(s) in the right column refer to the date(s) covered by the material in the manuscript collection. The rank, duty position, and assigned unit also refer to the subject in service in the AEF. The annotations only refer to material within the manuscript file that is related to the AEF. In many cases there is much more material in the file.
- B) An asterisk (*) immediately after the first name of the author or manuscript file name indicates that the annotation is based on the lengthier and more detailed description found in <u>Manuscript Holdings of the U.S. Army Military History Research Collection</u> (Dr. Richard J. Sommers, PhD, 1972, vol. 1 and 1975, vol. 2).
- **II.** World War One Veteran's Survey Description of Contents.
- **III.** Papers and oral history of World War II Generals (with WW I service) list of names (to be fully annotated in a future draft).

I. Manuscript Collection (working)

Alexander, Robert, 1885-1940

Major General, Commander 77th Division

Field Orders for the Meuse-Argonne Offensive, scrapbook with official and personal correspondence.

Allen, Terry, 1888-1969

Major, 358th U.S. Infantry Regiment 1888-1969; Some (limited) personal correspondence, official papers, and clippings related to his WW I service. Bulk of collection WW II related.

Argonne, Battle of, 1918

11th U.S. Field Artillery Regiment; Reminiscences of a Captain of the 11th concerning fighting, November 2, 1918.

Armor Magazine, 1861-1971

Office files of letters sent and received by the magazine. Includes letters related to the use of armor in WW I.

Atterbury, W.W., 1917-1919

Brigadier General, Director General of Transportation, AEF; Extensive and detailed documents pertaining to the establishment of the Transportation Corps and railroad issues/ problems/resolutions in the AEF. Atterbury was an American railroad executive directly commissioned to his important position. Typewritten manuscript <u>History of the Transportation Corps</u>. Reports concerning Allied cooperation, rates of supply, locomotive hauling, railway/depot construction and numerous related topics.

Barada, John J *, 1917-1919

Private, Sergeant, 12th U.S. Engineers (2nd U.S. Reserve Engineers); Transcript diary of his service in WW I, primarily his account of operations April 6 – May 12, 1919 on the Western Front. Includes photo and poem by A.R. Brandenburger.

Beary, Frank D.*, 1921-1945

Brigadier General, The Adjutant-General of Pennsylvania; Limited mention of the Guard during WW I is among the vast array of topics in this long serving (1917-1945) Adjutant-General's files.

Beatzhold, George J.*, Captain, 309th Field Artillery Regiment; Several operations orders, operations maps, and one terrain map for the 153rd Field Artillery Brigade, 90th Division, I Corps, 1st Army for the period September 9 – October 28, 1918.

Berry, Lucien G., 1884-1936

Brigadier General, 60th Field Artillery Brigade, 35th Infantry Division; Official maps and correspondence including award citations and overlays. Includes several letters concerning an investigation of 35th Division's conduct of operations.

Betzfelder, Karl B.*, 1916-1919

First Lieutenant, Medical Corps assigned to Base Hospital No. 48, then to the Medical Detachment at the Alpine Leave Area in Chamonix, and finally to Camp Hospital No. 76; Principal item is his detailed diary dated April 6, 1917-July 25, 1919. Betzfelder also convinced fourteen of his patients to record their recollections of their service in the war. These range from three to fifteen pages each.

Bliss, Tasker H., 1865-1968

Chief of Staff, U.S. Army; U.S. Delegate to the Peace Conference; Personal letters to his wife and others during his Washington duty that mentions AEF activities. Limited official correspondence related to the AEF.

Bloch, William *, 1915-1919

Corporal BTRY B, 48th Coast Artillery; Nine reminiscences by Bloch in the 1960's of his service just before and immediately after the armistice in France primarily concerning Coast Artillery.

Boyer, Perry L.*, 1877-1946

Medical Corps Officer, 92nd Infantry Division and Army Artillery/First Army; Extensive personal diaries written while in France. Also clippings and picture-postcards.

Broad, John W.*, 1918

Private, 4th Depot Battalion, Signal Corps; Two personal letters home describing his move from Fort Leavenworth, Kansas to England and then to France. Includes description of a submarine attack on his ship.

Brown, William Carey*, 1854-1942

Colonel, 42nd Division and Quartermaster Corps, AEF; Personal and official correspondence concerning his service as Inspector in the Quartermaster Corps in WW I.

Bruce, Andrew Davis*, 1916-1970

2nd Infantry Division; Large collection, substantial items related to AEF. Clippings and personal correspondence on WW I service, monographs concerning his division in WW I written while attending various service schools. Numerous official reports. Later became Lieutenant General

Buck, Beaumont B., 1890-1932

Brigadier General, Commander 2nd Infantry Brigade; Major General, Commander 3rd Division; Personal correspondence, including diary and reviews and recommendations for his book, <u>Memories of</u> Peace and War

Campbell, Donald *, 1917-1922

Lieutenant and Captain, 8th U.S. Machine Gun Battalion; Miscellaneous battle maps (8), special orders, promotions, leaves, etc. for Campbell who served as operations officer of the battalion during fighting in France.

Cantigny, Battle of, 1918

Eighteenth German Army, XXVI German Reserve Corps, 272nd German Reserve Regiment; Translation by Major P.B. Harn of official German orders and reports concerning operations around Cantigny, May 26 – June 6, 1918, particularly fighting on May 28.

Carswell, Stuart R.*, 1917-1923

Captain, Historical Section, Army War College; Copies of four letters to Dr. Lutz of the Hoover Institute for War, Peace, and Revolution written 1922-23 and discussing some activities of General Pershing and the 92nd Infantry Division.

Cavalry – 2nd Regiment*, 1836-1927

Capsule accounts of unit history.

Coast Artillery Corps*, 1880-1969

Larry J. Addington, <u>The Coast Artillery Corps: A Corps in Search of a Mission</u>, Carlisle 1970. The text of his presentation at the MHI, includes some description of AEF activity.

Coleman, Frederick W.*, 1899, 1918

Lieutenant Colonel and Colonel, Quartermaster and G-1, 91st Infantry Division Diary July 1-November 3, 1918 describes WWI operations.

Dewees. A. Draper, 1918-1919

Field Clerk, V and IX Corps Headquarters; A Draper Dewees, <u>Fifth Corps Headquarters</u> – a compilation of his wartime diaries and letters and official documents based on his service (July 30, 1918-June 6, 1919) at the Corps headquarters.

Cook, Henry*, 1917-1921

Private, 339th U.S. Infantry Regiment; Miscellaneous personal/official papers including draft and induction notices, firing practice, welcome from King George V, bible, songbook, commercial maps, and insurance forms. Photographs filed in Audio-Visual Department.

Corlett, James Harrison*, 1889-1964

Lieutenant, 30th US. Infantry Regiment; Large file includes some accounts of WW I service in his autobiography (unpublished, probably written 1948), personal and official letters, and photographs. Later became Major General.

Crain, R.K.*, 1918

Major, Ordnance Officer I Corps; Colonel, Ordnance Officer, Second Army; Three reports on ordinance operations: February, 1918; November 1918, and Oct-December 1918.

Crawford, William Baily*, 1913-1920

Private, 341st Field Artillery Regiment; Two service diaries and numerous personal and semi-official correspondence pertaining to himself and to his unit.

Cron, Anton Caesar*, 1878-1960

Major, 323rd U.S. Machine Gun Battalion and 330th and 28th U.S. Infantry Regiments; Detailed diary accounts of his front-line service in France.

Cutter, Walter L.*, 1898-1950

Coast Artillery; Includes diaries for the period 1918-1919 which include descriptions of his duties in the United States and France. File also contains a small collection of wartime clippings and poems.

Dorcy, Mrs. Gladys*, 1855-1970

Patroness of the 1st Cavalry Division; wife of Colonel Ben Dorcy, 7th U.S. Cavalry Regiment; A few items pertaining to his military career (including service in WW I) among 1st Cavalry Division records and memorabilia.

Drum, Hugh H., 1898-1951

Colonel and Brigadier General, Chief of Staff, First Army; Large Collection (36 boxes) including substantial correspondence and diaries concerning First Army and the AEF.

Eaker, Ira C.*, 1894-1972

Second and First Lieutenant, 64th U.S. Infantry Regiment; Capsule summary of life and career, 1962 interview, and 1966 interview all address the WW I activity of this future Chief of the Air Staff.

Evans, Fred*, 1898-1941

Lieutenant and Captain, Field Hospital Company No. 1, Medical Detachment, 2nd Division; Major, Medical Director, Field Hospital Section, 2nd Sanitary Train Miscellaneous official papers pertaining to Evans and his unit during WW I and the subsequent occupation of Germany. Especially important are tables showing admittance to his hospital and station reports, maps, etc.

Field Artillery – 7th Regiment*, 1980-1972

History and reminiscences of the unit including duty in Cantigny in 1918.

Fiske, Harold B. (Timberman-Fiske Family Papers), 1898-1934, 1948

Colonel and Brigadier General, G-5 (Training), AEF; Personal letters, official papers, reports and lectures. Many reports directly related to issues of WW I training.

Gage, Philip S., 1918-1944

Officer, Third Army, AEF; Personal letters and WW I ephemera.

Gill, William H.*, 1886-1973

Captain, Provost Guard, 5th Infantry Division; Among the transcripts of sixteen recordings of Major General Gill's recollections in 1973 is a description of his service in France.

Genealogy, Laning Family*, 1620-1967

Headquarters, American Expeditionary Force; 58th Brigade, 29th Division; Bureau of Navigation Robert Laning Clifford, <u>History of the Laning Family</u>, an unpublished typescript summarizing the family history including Brigadier General John McAuley Palmer II of the G-8 section, AEF and 58th Brigade Commander – 29th Division.

Gerhardt, Charles*, 1793-1937

Brigadier General, Intermediate Zone and later Base 7, Service of Supply, American Expeditionary Force; Brigadier General assigned to 35th Infantry Division and Commander, 183rd Infantry Brigade; Memoirs of military service, 1883-1927 including action in France during WW I.

Gerhardt, Charles Hunter*, 1895-1970

Captain, Aide de-Camp to Major General W.M. Wright commanding the II Corps and later the 89th Infantry Division; Autobiographical memoirs, and limited letters describe his experiences in the AEF. Later became Major General.

Godfrey Family Papers*, 1843-1960

Edwin S. Godfrey, Jr., Red Cross; Large collection. A small portion includes Dr. Godfrey's letters during his Red Cross service in France during WWI.

Gores, Walter J.*, 1916-1919

First Lieutenant, Section 552, U.S. Army Ambulance Service; Miscellaneous papers from the commander of an American ambulance section serving with the French army.

Hagood Family; Hagood, Johnson II, 1861-1948

Colonel and Brigadier General, Services of Supply. AEF; His manuscript, <u>Down the Big Road</u>, describes his military career including his WW I service July, 1917 – May 1919. There are also two typescript diaries covering his WW I service.

Halstead - Maus Family*; Halstead, Laurence, Sr., 1875-1971

Lieutenant Colonel, Chief of Staff, 84th Infantry Division; Colonel, G-3 First Army; Extensive holdings including memoirs of service with the 84th Division (1917) and with an observation team to British and French sectors in France (1917-1918). Also contains other 84th Division orders and Marshall Petain's attack orders of September 16, 1918.

Harbord, James G., 1917-1919

Major General, Commander, 2nd Division; Commander, Services of Supply; Text of 1930 speech to the Army War College: "Services of Supply, July 1918 – May 1919". Bound copy of 300 page official "Report of the Commanding General, Services of Supply, to the Commander in Chief" and a colorized copy of "Service of Supply" text published December 1918.

Hennessy, Harold Richard*, 1917-1945

Yearbook and first hand accounts (by a Private Carl Tett of the 364th U.S. Infantry Regiment) related to WW I service.

Hunt, Ora E.*, 1918

Brigadier General, 6th Infantry Brigade; Typescript copy of Hunt's lecture at the Army Center of Artillery Studies, Treves, Germany, May 14, 1919, describing a combined operation of the 38th U.S. Infantry Regiment and the 76th U.S. Field Artillery Regiment against Germans on Hill 252 during the Battle of the Argonne, October 9, 1918.

Hershey, Lewis B.*, 1893-1973

Captain, 137th, 10th and 82nd U.S. Field Artillery Regiments; Vast (eleven hundred boxes) collection of personal papers mostly concerned with his career with the Selective Service System (achieving the rank of General, Director of Selective Service System and advisor to the President) but does contain a capsule biography and few papers related to his service in France in 1918.

Hill, Charles W.*, 1917-1919

Private, 147th U.S. Field Artillery Regiment; Typescript volume compiled by Charles W. Hill in 1965, based upon his wartime diary and supplemented by other sources.

Hines, John L.,1868-1940

Colonel and Brigadier General, Commander 1st Brigade, 1st Division; Major General, Commander 4th Division; Commander, Third Corps.; Personal and professional letters as well as a manuscript biography written by Charles L. Bolte.

Hobbs Family*, Hobbs, Horace P., 1875-1957

Lieutenant Colonel, Inspector, 26th Infantry Division; Colonel, 102nd and 101st U.S. Infantry Regiments; Extensive holdings including official and personal correspondence covering his service in the 26th infantry Division.

Howard, Charles E.N., Sr.*, 1898-1937

Captain through Colonel, Quartermaster Corps; File contains miscellaneous official papers and official reports related to his duty at the Office of the Chief Quartermaster/AEF in France.

Infantry – 3rd Division*, 1917-1961

Numerous historical references in an album of correspondence, speeches, and brochures, 1957-1961, dealing with the dedication of division's monument on the battlefield of Chateau Thierry, France, October 8, 1961.

Infantry – 28th Division*, 1747-1968

Major Severino Stefanon's unpublished <u>28th Division</u>, <u>Pennsylvania-Maryland-Virginia Army National Guard</u> summarizes the unit's history including past commanders and events. Lieutenant General Edward Stackpole's <u>Boalsburg Address</u> of May 21, 1967 concerning the family of Colonel Theodore Davis Boal's service as aide-de-camp to Major General Charles H. Muir (28th Infantry Commander during WW I) also describes the creation of a memorial to the division at Boalsburg, Pennsylvania. Collection also has a memo (May 24, 1918) from Major General Muir prohibiting nonofficial use of official stationary.

Ireland, Gordon*, 1912-1920

Sergeant and First lieutenant, 1st New York National Guard Signal Battalion; First Lieutenant and Captain, 102nd and 211 Field Signal Battalions; Miscellaneous personal and official papers, maps, and clippings related to his service with the 27th Infantry Division in the AEF.

Jarret, George Burling*, 1805-1814, 1890-1971

Lieutenant through Colonel, Ordnance Corps; Colonel Jarret headed two ordnance-related museums and his numerous descriptions of WW I aircraft highlight this wide-ranging collection. Illustrations and movies are deposited in the Audio-Visual Department.

Jean, George W.*, 1874-1964

Major, Medical Corps, Base Hospitals Number 58 and 238, American Expeditionary Force; Served in two hospitals in France during WW I. Voluminous diaries offer detailed observations on life at the front in general and in the hospital service in particular. Also reminiscences of the war.

Jones, Harry E.*, 1936-1968

Large eclectic collection of personal historical documents/artifacts. Includes several published articles including one related to WW I: Craig S. Herbert, "Gasbags Preferred, the American Balloon service in World War I", Aerospace Historian, v. XV, no. 2: 26, 39-51, 1968.

Kemp, Harold Augustus*, 1894-1952

Private through Sergeant, Provisional Company Q, Ordnance Base Depot in France (later in the 5th Heavy Mobile Ordnance Repair Shop); Capsule biographies, 1894-1951, and autobiographical outlines, 1894-1944 summarize the professional highlights of his life including his service in France. These comprise a small portion of this distinguished engineer's papers.

Kincaid, James Leslie* ,1884-1963

Major and Lieutenant Colonel, 27th Infantry Division; Capsule biography summarizes his WW I service.

Koenig, William C., 1914-1926

Major, Office of the Chief Purchasing Officer, Quartermaster Corps, AEF; Lieutenant Colonel, Office of the Chief f Artillery, AEF; Official (his "US Artillery Program" report, for example) and personal correspondence concerning Koenig's wartime service. His translations of reports from senior German offices are also in this file.

Kromer, Leon P.*, 1894-1941, 1954

Colonel, G-1, First Army; Base Section 9 and General Headquarters, Service of Supply; Among this large collection of personal and official papers are brief references to his service in WW I.

Lemmon, Kelley B.*, 1814-1815, 1907-1929

Major, 55th Ammunition Train; Official correspondence and papers to and from Lemmon near Angers, France.

Lenihan, Michael Joseph*, 1865-1958

Colonel and Brigadier General, Commander, 83rd Infantry Brigade, 42nd Infantry Division; Commander 153rd Brigade, 77th Division; Michael J. Lenihan, <u>I Remember—I Remember</u>, unpublished reminiscences dictated by General Lenihan in 1958 covering his early and military life including his AEF service.

Livesay, William G.*, 1914-1956

Captain, Adjutant, 28th U.S. Infantry Regiment; Official correspondence, reports, and historical studies concerning the 28th U.S. Infantry Regiment and the 1st Infantry Division, 1917-1919. Later became Major General.

Longuevan, Joseph B.,1917-1990

Private and Sergeant, 31st U.S. Infantry Regiment, AEF – Siberia; Large (38 boxes) collection primarily centered on service in Russia but including discussions with other veterans on WW I in general.

MacMoreland, Edward E., 1892-1978

Adjutant, 33rd Coast Artillery Brigade; General Officer's oral history discusses service in France. Personal letters from both his service in France and service in Russia.

Maginnis, John J.*, 1917-1919, 1943-1946

Lieutenant, 301st U.S. Infantry Regiment; 163rd U.S. Infantry Regiment; and the 42nd Division; Most of this file contains items on his <u>post WW II</u> service in civil affairs in Germany but there are a few references to his WW I career especially clippings and some official forms.

Marshall, S.L.A.*, 1918-1970

Numerous official maps, charts and graphs presumably provided for his research. No interview notes for WW I are included in this collection.

McLaughlin, Clenard*, 1895-1944

Colonel, Inspector General's Department; Chief of Staff and Inspector, 8th Infantry Division; Transcripts of three interviews the bulk of which concerns service in Puerto Rico and the Philippines but includes a brief discussion of his duties with 8th Infantry Division in the time of the Armistice and Occupation.

McLaughlin, Joseph M.*, 1915-1948

Sergeant, Coast Artillery Corps; Joseph M. McLaughlin, <u>Collision in the Atlantic</u>, an unpublished account of the collision of the U.S. troopship <u>Great Northern</u> and the British freighter <u>Brinkburn</u>, October 3, 1918. He was a passenger on the <u>Great Northern</u> and also tells, in the unpublished manuscript, of his subsequent service with the 54th Coast Artillery Regiment in France.

Millen, Richard B.*, 1917-1919

Private, 5th U.S. Marine Regiment; Capsule memoirs, written in 1974, outlining the highlights of his service with the 5th Marines in 1918. Commentary on the Marine Corps and the 2nd Division in WW I.

Missoula, Fort*, 1792-1932

<u>History of Fort Missoula</u>, Montana, written in 1927 includes a description on the 4th Infantry division's activities in WW I.

Moncrief, William H., 1876-1973

Doctor, WW I; Collection summarizing army medicine through WW II including his own experiences in WW I. Discusses large field hospital operations and procedures for patient care. Includes official and personal correspondence during WWI.

Moore, Oswald D.*, 1916-1945

Second Lieutenant, 108th U.S. Field Artillery Regiment; Second and First Lieutenant and Captain, 107th U.S. Machine Gun Battalion; Personal Correspondence, memoirs, miscellaneous official papers, and clippings related to his service in the 28th Infantry Division.

Mueller, Paul J*, 1892-1964

Commanded the 81^{st} Infantry Division during and after <u>WW II</u>; His papers do include some divisional history related to the unit's actions during WW I.

Myers, Roy V.*, 1914-1919

Captain and Major, 114th U.S. Field Artillery Regiment; Memoir based on wartime diaries of his service including St. Mihiel and the Meuse Argonne Offensive.

Nolan, Dennis E*, 1918

Brigadier General, G-2 AEF, 55th Infantry Brigade Commander; Official report of operations of the 55th Infantry Brigade in the Meuse-Argonne Offensive, September 28-Oct 9, 1018. Appended to the report are four orders issued to the brigade by 28th Infantry Division headquarters during that period. Other papers related to G-2 work including German and American documents. Reflections and postwar commentary.

North, Thomas, 1917-1922

Lieutenant, 11th Engineers; GHQ, AEF; General Officer's papers covering 51 years of service. Includes reports of mapping at HQ, AEF. Description of engineer attack at Cambrai in 1917.

Oliver, Raymond O., 1918-1922, 1941-1957

Private, Headquarters Medical and Surgical Consultants, AEF; File is mostly concerned with subsequent WW II service in North Africa and ETO but does contain a letter from one doctor to another discussing WW I medical care.

Patton, George S. Jr., 1845-1945

1st Tank center, AEF; Limited personal letters to and from Patton during WW I.

Poore, Benjamin A., 1880-1942

Brigadier General, Commander 7th Infantry Brigade, 4th Infantry Division; 50 page typeset autobiography My Experience in the American Expeditionary Forces, 1918-1919. Based on his (included) handwritten diary. Recounts personal and official activities as commander.

Reilly, Henry J., 1917-1938

Colonel. Commander 67th Field Artillery Brigade, 42nd Division; Large collection including substantial material on artillery operations during the war within his division (operations orders, plans, etc.).

Charles D. Rhodes,

Brigadier General, 157th Field Artillery Brigade, 82nd Division; Major General, Commander 42nd Division; 100 pages of typewritten diary entries (transcribed from missing diary) covering every aspect of command including official and personal experiences. After the war he was appointed to the Permanent Allied Armistice Commission – this experience is included in the same diary.

Sawbridge, Benjamin M.*, 1918

Lieutenant and Captain, 13th U.S. Field Artillery Regiment; Diary of service in North Carolina, New York, and France, January 1-December 31, 1918.

Sheldon, Raymond, 1917-1919

Lieutenant Colonel and Colonel, Commander, 307th Infantry Regiment, 154th Infantry Brigade, 77th Division; Provost Marshal General's Department, AEF; Field orders and operation reports by Battalion and Company Commanders of 307th Infantry. Battle maps of France. History of Bureau of Prisoner of War operations July 1917 – September 1919.

Sladen Family*, Sladen, Fred W., BG, 1863-1969

Commanding 5th Infantry Brigade, 3rd Infantry Division; Large collection on the distinguished military career of three Sladens. Significant file of Fred's military and personal letters written while commanding a brigade fighting in France. Photos related to AEF service have been transferred to the Audio-Visual Department. Fred Sladen later became Major General.

Spalding, Sidney P., 1889-1981

Office of the Chief of Ordnance, AEF; Memoir includes reference to WW I ordnance work.

U.S. Navy—Negro Service, 1775-1918

TLS, Commander J.H. Sypher, Superintendent, Office of Naval Records and Library of the Navy Department, to Miss N.C. Barndollar, Librarian, Army War College, December 10 1924, summarizing the service of Negroes in the US. Navy from the Revolutionary War through World War I. This three-page letter cites numbers of men involved and specifies a few instances of individual behavior.

Vandeman, Ralph H., 1897-1919, 1949

Staff Officer, G-2, AEF; General Officer's memoir and letters on origins of military intelligence and counter intelligence.

Walgren, Abian, A., 1911-1948

Marine Corps Enlisted Man, detailed AEF; Papers of <u>Stars and Stripes</u> cartoonist include examples of his work as well as personal correspondence with wartime friends, and attempts to obtain military decorations for AEF service.

Wells, Briant H.

Colonel and Brigadier General, Chief of Staff VI and IV Corps; 100 pages of official reports gathered while Chief of Staff. Also includes his AEF identity card.

Weintraub, Stanley, 1918-1941

Papers collected for two published books. <u>A Stillness Heard Round the World</u> concerns the WW I Armistice while the second is about the Japanese attack on Pearl Harbor. The collection includes recollections of participants, tape recorded memoirs, and various interview notes.

Woodward, Harold C., 1903-1932

Officer, Remount Service, Quartermaster Corps, Services of Supply, AEF; Letters to home concerning purchases of horses and other activities.

Washburn, Frederic A., 1898-1922

Medical Officer, 6th Base Hospital, Base Section 3, AEF; Correspondence with family and friends in New England while serving in England and France.

II. World War I Veterans Survey

Beginning in 1975, the Military History Institute launched an appeal to all surviving WW I army veterans to complete a detailed questionnaire and submit any WW I personal or official documents to the Institute. Over 7000 veterans or families of veterans responded to the call. The holdings in this collection are detailed in the Military History Institute's Special Bibliography 20, Volume 1: World War I Manuscripts, The World War I Survey (Hermine Scholz and Richard J. Sommers, 1986).

III. World War II Generals – this list includes those generals with experience as officers in the AEF during World War I. In some cases the holdings include extensive or quite limited manuscript collections, in others oral history transcripts, and in others a combination of the two. Future drafts of this bibliography will specifically annotate the holdings as is the case in section I, above.
